The project scope involves four laning of Mahuva to Kagavadar section of NH-8E from Km.100.100 to Km 139.915 (Design Chainage from Km. 100.450 to Km. 140.470) (Package – III) under NHDP Phase IV.

The Bid Project Cost is Rs. **604.68** Crores and the first year O&M Bid is for Rs. **8.46** Crores. The Construction period is of 2 years and 6 months from the appointed date and the Concession period is 15 years excluding the Construction period.

The Company continues it's winning run as it now have a basket of 6 HAM projects in the states of Maharashtra and Gujarat totaling to Rs 3836.99 crores.

This project is under the new Hybrid Annuity Mode, which is a mix of engineering, procurement and construction (EPC) and build operate transfer (BOT) system.
