

MEPIDL's subsidiary acquired 4 NHAI Toll Collection Projects in the State of Tamil Nadu

- Received Letter of Award for 4 short term Toll Collection Projects for 90 days in the Madurai Kanyakumari section in Tamil Nadu –

Mumbai, September 12, 2016: Raima Toll & Infrastructure Private Limited (“RT&IPL”), a Wholly Owned Subsidiary of MEP Infrastructure Developers Limited (‘MEPIDL; BSE: Script Code: 539126; NSE Script Code: MEP) has acquired 4 short term toll collection projects in the State of Tamil Nadu for a period of 90 days.

RT&IPL, has received the Letter of Award for Toll Collection at:

- (i) Salaipudhur Fee Plaza
- (ii) Ettuvattam Fee Plaza
- (iii) Kappalur Fee Plaza and
- (iv) Nanguneri Fee Plaza

On NH-7 in the State of Tamil Nadu (Madurai-Tirunelveli – Panagudi – Kanyakumari Section).

The subsidiary has committed to a remittance of the following amounts to the authority (NHAI) for the above mentioned projects over the project tenure, payable on daily basis:

- (i) Salaipudhur Fee Plaza is Rs. 10,80,000/-
- (ii) Ettuvattam Fee Plaza is Rs. 10,80,000/-
- (iii) Kappalur Fee Plaza is Rs. 13,50,000/-
- (iv) Nanguneri Fee Plaza is Rs. 11,34,000/-

The operations will commence within 5 working days after complying with the statutory formalities viz. submission of performance security, signing of contract as per the LOA.

With the 4 new projects awarded, MEP further strengthens its presence in the State of Tamil Nadu with the company's total short term project portfolio now strengthened to 14 short term toll collection projects awarded by NHAI spread across 8 states in the country.
