

PRESS RELEASE

MEP RGSL Toll Bridge Pvt. Ltd. (A subsidiary of MEP Infrastructure Developers Limited) is carrying out renewal / resurfacing by bituminous material of Rajiv Gandhi Sea Link. 80 % of the work is already completed.

The Sea Link is having 2 + 2 lanes towards the Worli end. Due to availability of only 2 lanes on either side, it is not possible to carry out the renewal work even at night. As such it is essential to close the traffic for execution of the work on any one side each day.

To carry out the renewal work, it is proposed to close the traffic plying from Bandra to Worli from 10.00 pm on Monday 02nd May, 2016 to 06.00 am on Tuesday 03rd May, 2016 on Rajiv Gandhi Sea Link.

Similarly it is proposed to close the traffic plying from Worli to Bandra from 10.00 pm on Tuesday 03^{rd} May, 2016 to 06.00 am on Wednesday 04^{th} May, 2016 on Rajiv Gandhi Sea Link.
