Dear Sir,

I, CS Dinesh Joshi, Designated Partner, KANJ & CO. LLP, Company Secretaries, Pune appointed as a Scrutinizer.

- 1. The remote e-Voting process was conducted for the below mentioned resolutions, as per Section 108 of the Companies Act, 2013 and Rules made there under from 30th July, 2018 (9:00 a.m.) to 1st August, 2018 (5:00 p.m.).
- 2. Members who do not have access to the remote e-voting facility have voted by way of Ballot Forms provided along with Notice convening the Annual General Meeting. We have considered only such Ballot Forms which were received before 5.00 p.m. on 1st August, 2018.
